When service is attached to the order, like service will be added to the beginning of the contract period for a one-year period. With Platinum Service no additional batteries or print heads will be provided over the additional year.

For equipment orders to be eligible for free service, orders must be placed and ship between 1/01/2022 and 12/31/2023.

Distributor to claim promotion by placing a zero-value purchase order with the completed trade-in form for each claim to the usual service ordering point.

Trade-in product must arrive at the Honeywell Processing Center at Honeywell Trade-In Program, 13509 South Point Blvd, Charlotte, NC 28273 (freight prepaid) within 90-days of invoice for the new equipment.

If units are not received within 90 days of invoice for the new equipment, Honeywell reserves the right to issue a full cost invoice for service payable by the partner. The distributor will not be held responsible for any charges that cannot be recovered.

The number of new units purchased that will have free service will be determined by the number of eligible units traded-in and the corresponding number of eligible

new units purchased (a 1:1 ratio of like products).

Trade-in units must be in working condition when received at the Honeywell Processing Center. Free one years' service will not apply for non-working units.

End customer must submit the **Trade-In Rebate Form** from your local Honeywell sales rep.

Standard lead times apply to orders for devices.

Honeywell has the right to change, modify, or cancel the promotion at any time.

Account must be current and in good standing to participate.

Standard terms and conditions of your distribution agreement apply.

Product must be purchased from an authorized United States and Canada Honeywell Distributor.

Any claims related to this rebate must be submitted prior to January 31, 2024.
